Sir,

With reference to the above-cited subject, please find enclosed letter received from Department of Electronics and Information Technology (DeitY), Govt of India, dated 12/11/2014 regarding amending the procedure for securing a Life Certificate for the purpose of disbursement of pension to a very large number of pensioners by using digital medium.

As per the extant procedure, Pensioners, have to submit a Life Certificate in prescribed format to the Pension Disbursing Agency in November every year to avail continued receipt of pension without interruption. This causes hardship particularly to those who are aged and/or infirm Pensioners.

To overcome above situation, Department of Electronics and Information Technology (DeitY), Govt of India has developed "Jeevan Pramaan- Digital Life Certificate" portal <u>www.jeevanpramaan.gov.in</u> in which a Life Certificate is issued online (through Aadhar Biometric Authentication.

This will aid in simplifying the process of submission of life certificate and facilitating accuracy and timeliness in disbursal of pensions.

In view of above, it is requested to initiate necessary action to issue and accept the procedure of Digital Life certificate and to notify the amendment to the respective pension regulation as per the Correction' slip No 22, mentioned in the Letter No CPAO/Tech/Amdt.Sch.Book/2014-15 dated 10/11/2014 issued by the Department of Expenditure, Central Pension Accounting Office, Govt of India.
